FOR RETURNING TO SCHOOL FALL 2020

CSA RISE: Restarting through Innovative Sustainable Education

OPTION A: AT SCHOOL BUILDING

5 days a week, following district calendar

OPTION B: AT HOME

via CSA RISE Innovative Learning Plan, 5 days a week, full-day of instruction, following district calendar



HEALTH/SAFETY

Enhanced health and safety measures

- CDC compliant cleaning of facilities
- Monitoring of student health for symptoms
- Practical social distancing
- Limited visitor access
- No large group activities
- PPE for students and staff as required (masks)
- Hand sanitizer stations
- Contact tracing
- Accommodations for medically fragile
- Access to eLearning in the event of illness
- Limited movement of students

Enhanced Social/Emotional Learning

- Recommended for medically vulnerable students or those with vulnerable family members
- Interaction with peers and teachers through Innovative Learning platform
- Avoids additional transition to unfamiliar setting and/or platform
- Social/Emotional support with age appropriate group sessions via eLuma telehealth services.
- Individual counseling as needed via Regional Mental Health Counselors



LEARNING

Safe/health informed, direct instruction

- Traditional brick and mortar school environment
- Teacher directed instruction
- Access to labs, manipulatives, and instructional materials
- Project-based instruction
- Tutoring
- Individualized instruction
- Traditional schedule
- Full food service

Innovative learning experience and platform

- Teacher directed instruction in a Microsoft classroom
- Peer to peer engagement via Microsoft platform
- Ongoing assessment
- Accommodations for students with 504s and IEPs
- Progress monitoring
- Opportunity to return to physical school at end of grading period or semester
- Student collaboration through Microsoft Teams
- Substantially similar to in-school instruction



WHAT TO CONSIDER

When selecting Option A:

- Students will be expected to be in regular attendance (regular absentee policy applies)
- Your selection is for a grading period, minimum and a semester, maximum (subject to change)
- PPE is required in cases where social distancing cannot be achieved
- New safe and healthy procedures will be in place
- If required, school closures will follow CDC recommendations
- Symptomatic students should remain at home
- If schools do not physically open on the planned start date, all students will learn via innovative learning online

When selecting Option B:

- Consider your family circumstances carefully
- Your child will fully enroll in his/her current charter school
- Your selection is for a grading period, minimum and a semester, maximum (subject to change)
- Consider your technology needs (devices, internet, etc.)
- You will be using a school issued Office 365 account and email
- School assignment and grading practices apply
- School discipline and digital citizenship rules apply
- Instructional time will follow the daily/bell schedule of your child's school
